Once the intermediary has been appointed, the Court has authorized him/her to charge \$250.00 plus costs (phone, postage, any documents that might need to be obtained from any agency). This fee is not due until the intermediary has contacted you and the CI will not begin the search until the fee is paid. If you have not made payment after six months, your file will be dismissed and you will need to petition the Court again, requiring an additional \$20.00 filing fee.
- Please provide picture identification and a copy of your birth certificate.
- Please complete the enclosed form(s).
- If you received non-identifying information from an agency, please submit a copy.
