MULTIPLE-DISTRICT PLAN FOR MAGISTRATES

This Administrative Order rescinds and replaces Local Administrative Order 2004-12J.

IT IS ORDERED:

This Administrative Order is issued in accordance with MCL 600.8251 and MCL 600.8320 effective July 1, 2009. The purpose of this Order is to allow two or more district courts within a county to establish a multiple district plan upon the approval of the State Court Administrative Office.

- 1. The 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26-1, 26-2, 27, 28, 29, 30, 31, 32A, 33, 34, and 35 District Courts within the County of Wayne establish a multiple district area for the purpose of conducting weekend and holiday arraignments under the direction of the Third Circuit Court.
- 2. Those district court magistrates within the multiple district area with whom the Third Circuit Court has or will enter into a contract for weekend/holiday arraignment services are authorized to conduct arraignments and set bail or recognizance for all of the participating districts within the multiple district area for purposes of the weekend arraignment program.
- 3. All district court magistrates under this multiple district plan have been or will be appointed under MCL 600.8501 and nothing in this plan shall grant powers or duties to the district magistrate that are not authorized by statue or that exceed the authorization of the chief judge in which the magistrate is acting.
- 4. The cost for the district court magistrates under this program is funded from each participating district court's advance payment of an equal share of the annual expense (i.e.; 1/21). Payments will be directed to the Third Circuit Court and made payable to the "WHAP Magistrate Fund" no later than November 1st for the following calendar year of WHAP service, with the first full annual payment due November 1, 2009. The annual expense is determined as follows: 121 (weekend/holidays to be covered yearly) x \$100 (rate per day) ÷ 21 district courts = \$576.19. District courts shall be notified in advance of the November 1st due date of any amendments or changes to the factors determining the annual expense.
- 5. For this period only, each participating district court shall forward, no later than June 12, 2009, an amount of \$300.00 to the Third Circuit Court WHAP Magistrate Fund. This proportionate payment covers magistrate service from July 12, 2009 through December 31, 2009 (63 days).
- 6. All district court magistrates under this plan are subject to the superintending control of the Chief Judge of the Third Circuit. The Third Circuit Court shall compensate the magistrates presiding over weekend/holiday arraignments using the district court payments made to the WHAP Magistrate Fund.
